






















Officer Comments WFDD Meeting 03.22

On Wednesday, March 23, 2022, I, Deputy C. Bronsell, badge #1144, worked extra employment for WillowFork Drainage District from 4:30pm until 7:30pm. I began by patrolling around Creech Elementary, The Ballard House, and Exploration Park. I sat stationary in the parking lot, which contained 17 vehicles. I patrolled the levee to Summer Pointe playground and practice fields. I patrolled the levee to Emily Park Lane, and then to Beck Jr. High. I sat stationary on the levee, near the tennis courts. I patrolled through the parking lot of the South Ranch pool, which contained only 5 vehicles. I patrolled the levee around Williams Elementary, across Peek Rd, and to S.H. 99. I sat stationary on the levee near S.H. 99. I worked a total of 3 hours. I did not observe any motorized vehicles on the levee during my shift.

On Saturday, March 26, 2022, I patrolled the levee from 1:30pm until 6:30pm. I began by patrolling the levee around the Highland Community Park and practice fields, located near Blackwood Bridge Ln. I patrolled the levee around Kilpatrick Elementary, and the Highland pool & playground. I patrolled the Bayou North Side Trail, making stops at Sandi Ln, Banksfield Ct, and Glenthorpe Ln. I patrolled the new walking path, which travels underneath the 24200 block of Westheimer Pkwy. I observed the new graffiti painted in this location, which was first discovered by Deputy Tanner on Friday. I continued patrolling to WillowFork Park, and sat stationary in the parking lot, which contained 57 vehicles. I patrolled around Cinco Ranch High School and then made my way to the 24500 block of Roesner Rd. I observed what appeared to be dirt bike tracks in this area, just West of Falcon Landing Blvd. I then traveled in a Southeast direction, patrolling the levee near Heritage Grand subdivision, the playground near Finbury Ln, the levee behind Fry Ct, and up to the Army Corp of Engineers. I patrolled to Exploration Park, which contained 37

vehicles. I then patrolled the levee to the recreation center of Canyon Gate. I worked a total of 5 hours. I did not observe any motorized vehicles on the levee during my shift.

On March 25, 2022, I began my shift at Exploration Park where the park was busy with parents and children enjoying the day. There were 25 vehicles parked on the lot. I patrolled my way past Beck Jr High School that was busy with school activities. The paths were busy with mostly children walking home from school. I continued to the pedestrian bridge without incident. I remained in the area of the pedestrian bridge and

Beck Junior High School for an extended period without incident.

I then crossed the pedestrian bridge and traveled to Willow Fork Park. I traveled the Grand Parkway Underpass toward the Westheimer Parkway underpass. No new Graffiti was observed under the Grand Parkway Underpass. I made my way to the Westheimer Parkway Underpass where no new graffiti was observed. I made my way to Willow Fork Park where there were 27 vehicles on location. The park traffic was increasing while on location. I observed security patrolling the area during my patrol. I then traveled back toward Cinco Ranch High School and crossed the pedestrian Bridge to Falcon Landing Boulevard. I patrolled the area between the Westheimer Parkway underpass and Falcon Landing Boulevard for an extended period without incident.

I traveled under the Westheimer Parkway underpass back toward the Grand Parkway Underpass with no damage or graffiti discovered at each. I crossed the pedestrian bridge to the crossover path. I remained between Beck Jr. High School and the crossover path for an extended period without incident.

I patrolled to Exploration Park where there were 32 vehicles on the lot. I parked on the levee across from the park by the Canyon Gate subdivision. While sitting next to Mason Road a golf car drove up from the Canyon Gate Subdivision and was stopped prior to the levee. I made contact and discussed that driving on the levee was illegal. I remained in this area for the remainder of my shift without incident.

3:00pm till 3:30pm I sat in the parking lot. While I was there I counted about 17 vehicles in the parking lot but I did not see anyone from on-site security at the park. I then rode the levee to The Bowl where I crossed over the pedestrian bridge and rode the section of the levee which

I then rode to Willow Fork Park and checked the outer perimeter and parked by the front parking lot for a while. I noted eighteen vehicles in the parking lot on this date. I further observed in the parking lot a white truck with a high sided lowboy trailer which had lawn care workers. The workers were cutting the grass of the park with zero turn mowers and weed eaters.

I then rode to and sat between Banning Point Ct and Litchfield Bend Ln. on the levee.

I rode to and checked Highland park where I sat for a while near the open playing fields. I rode to and sat for a while near the overpass on Westheimer Parkway due to reports of criminal mischief under the bridge area. No incidents to report on this date. I also checked the diversion channel and the walkover bridge between Fry Rd. and Peek Rd. due to complaints of four-wheeler traffic.

I then rode to and sat for a while at Wellbrook Ln. and Arbor Stream Ln on the levee. I further rode to walk over a bridge near Freedom park where I sat for a while.

I rode to and sat for a while near Cassidy Park Ln. and S Mason Rd. Near the golf course area. Toward the end of my shift, I rode and sat between Exploration Park and The Ballard House. I noted ten vehicles in the parking lot near Exploration Park. I also noted near Mason. Rd. A white Chevy pickup parked on the south-east grassy area with several lawn care workers. The truck had a placard on the driver's door from Champion lawn service company.

I encountered only authorized motor vehicles, equipment and workers on the levee system this date.

Fork Park. From about 7:00 pm till 7:30 pm I sat in the parking lot and while I was there I counted about 45 vehicles in the parking lot and talked to Matt with on-site security. I did not see any motorized vehicles on the levee during my shift.

On April 1, 2022, I started riding the Willow Fork Levee at Kilpatrick Elementary School, from there I rode the levee to The Bowl where I headed north on the levee. I rode the levee to the pedestrian bridge located near The backside of Freedom Park. I then rode the section of the levee which runs behind Kelliwood Greens Dr and Spyglass Hills. I

then rode the section of the levee which runs by Beck Junior High School and out to Exploration Park. From about 5:00 pm till 5:30 pm I sat in the parking lot of Exploration Park and while I was there I counted about 22 vehicles. I then doubled back to The Bowl and rode the levee to Willow Fork Park where from about 6:00 pm till 6:30 pm I

sat in the parking lot. While I was there I counted about 57 vehicles in the parking lot and I did not see anyone from on-site security while I was there. I did not see any motorized vehicles on the levee during my shift.

On April 2, 2022, I began the shift by Kilpatrick Elementary by Gaston Rd.

I patrolled across the diversion channel to the pedestrian bridge by Kelliwood Greens. III then crossed the bridge and followed the nature trail to Exploration Park. While at Exploration Park I counted 20 vehicles in the parking lot. I sat by the parking lot for approximately 45 minutes and watched the visitors come and go.

I went to the Renberg pedestrian bridge and sat and watched the pedestrian traffic. It was extremely busy on the trails today.

I checked the viewing platforms and nature trails throughout the shift.

While patrolling back to the west side of the diversion channel I noticed spray paint on the pedestrian bridge that is just south of Finbury Lane. The spray paint is on the railing of the bridge. I took a picture of the graffiti and will attach it to my summary.

Just as I was about to cross Cinco Ranch Blvd. I was flagged down by a woman walking her dog on the sidewalk of Cinco Ranch Blvd. She wanted to tell me about the alligator that was in the pond by the Tennis Courts Cinco Ranch Westside.

I continued on to Willow Fork Park. While at Willow Fork park I counted 41 vehicles. I also saw Mike with On-Site security making his rounds in the golf cart. I sat by the parking lot for approximately an hour.

I then went to the Highland Community Park and sat for a few minutes.

During the shift I did not observe any suspicious activity or motorized vehicles.

On April 3, 2022, I began the shift on Gaston Rd. by Kilpatrick Elementary.

I first patrolled Cinco Ranch Jr. and Sr. High Schools.

I went to Willow Fork Park. While at Willow Fork Park I counted 21 vehicles in the parking lot. I sat by the parking lot for approximately an hour. While sitting by the parking lot, I was approached by a female who advised she could not figure out how to get to the tennis courts at the high school. She advised she walked over from the courts to the restroom at the park and now the gate she used to get through the high school fields is now closed. I provided her a courtesy transport back to the tennis courts. I sat by the parking lot for a bit longer and continued with my patrols and by the time I left the park there were approximately 34 vehicles in the parking lot.

I patrolled to the bridge by Kelliwood Greens and came back around on the trails to Beck Jr. High.

I checked the viewing platforms and the nature trails numerous times throughout the shift. I went to Exploration Park, While at Exploration Park I counted 18 vehicles in the parking lot. I sat by the parking lot for approximately an hour. While sitting and watching the parking lot the amount of vehicles grew by 15.

I patrolled over to the bridge on Peek Rd. by the water treatment plant. I sat at this location for about 30 to 40 minutes.

I moved and sat by Bayou North Side Trail due to the previous complaints of dirt bikes. I moved back and forth from Bayou North Side Trail to the bridge at Falcon Landing until the end of the shift.

I patrolled the levee around the high school and then patrolled the Bayou South Side Trail to Roesner Rd. I then rode the levee to Willow Fork Park where from about 3:45 pm till 4:15 pm I sat in the parking lot. While I was there I counted about 12 vehicles in the parking lot and I saw Jorge with on-site security making rounds. I then rode the levee to The Bowl where I crossed over the pedestrian bridge and rode the section of the levee which runs by Beck Junior High School. I

continued to ride the levee over to Exploration Park where I counted about 3 vehicles in the parking lot. I did not stop at Exploration Park I continued riding the levee down to about where Canyon Gate Subdivision ends. I then doubled back to Exploration Park and saw there were only 3 vehicles in the parking lot. I then rode the levee to the pedestrian bridge located near the back side of Freedom Park. I then rode the section of the levee that runs behind Kelliwood Greens Dr and Spyglass Hills. After that I rode back to The Bowl where from about 6:00 pm till 6:30 pm I sat by the walking path. I then rode the levee to The Bowl where I crossed over the pedestrian bridge and rode the section of the levee which runs by Beck Junior High School and out to Exploration Park. From about 4:50 pm till 5:20 pm I sat in the parking lot and while I was there I counted about 22 vehicles in the parking lot. I then rode the levee to the pedestrian bridge located near the backside of Freedom Park. I then rode the section of the levee which runs behind

Kelliwood Greens Dr and Spyglass Hills. I then rode back to The Bowl where from about 6:15 pm till 6:40 pm I sat and watched the walking path. While riding to Exploration Park, I noticed that bridge #19 by Peek Rd. has damage to one side of the railing. There are also some missing pickets in the fence line. It looks as if someone damaged it by running into it with something or kicking the boards out.

I then went to Exploration Park. While at Exploration Park I counted 20 vehicles in the parking lot. I sat close to the parking lot for about a half hour and watched the vehicles come and go. I then went around to the Kelliwood Greens subdivision and made the U-turn at the pedestrian bridge.

I patrolled behind Cinco Ranch Jr. and Sr. High Schools.

I went to Willow Fork Park. While at Willow Fork Park I counted 27 vehicles in the parking lot. While sitting next to the parking lot I saw Mike with On-Site Security making his patrols around the park in the golf cart.

I did not observe any suspicious activity or motorized vehicles during the shift.

On April 24, 2022, I began the shift by Kilpatrick Elementary near Gaston Rd. I first went to the new underpass at Falcon Landing. I noticed new spray paint underneath the bridge. I photographed the graffiti and attached it to the report.

I then patrolled over to Exploration Park. While at Exploration Park I counted 19 vehicles in the parking lot. I moved west of the park by the Willow Fork picnic tables and sat under the trees for approximately an hour and watched the parking lot.

Despite the high winds there were alot of people on the nature trails today.

I checked the viewing platforms and nature trails numerous times throughout the shift. I then went around to the Kelliwood Greens subdivision and made the U-turn at the pedestrian bridge.

I sat by the pedestrian bridge near Westbrook Cinco for a few minutes.

I moved and sat by the water treatment plant by the bridge on Peek Rd. While sitting there a Fort Bend County Pct. #1 Deputy pulled up and I sat and talked with him in the median for a short time. While we were talking, Fort Bend County dispatched a call for a four wheeler riding on the diversion channel. I went east towards the location and was crossing over the Renberg Pedestrian bridge when I observed a black male driving and a small female riding on the back of the black racing style four wheeler on the opposite side of the diversion channel. The driver had a full helmet on with a reflective lens. The Pct. #1 Deputy saw the four wheeler crossing over Peek Rd. and activated his emergency equipment. The four wheeler stopped on the west side of Peek Rd. just past bridge #19. The Deputy advised while he was walking up to the four wheeler he told the driver to turn off the atv. The Deputy said the guy hesitated for a second then sped off at a high rate of speed down the diversion channel towards highway 99. When I crossed Peek Rd. the four wheeler was out of sight and I did not give chase nor did the Pct. #1 Deputy. I patrolled west towards Highway 99 and crossed over Cinco Ranch Blvd. I patrolled behind Cinco Ranch Jr. and Sr. High Schools.

I went to Willow Fork Park. While at Willow Fork Park I counted 20 vehicles in the parking lot. I sat by the parking lot for a few minutes and continued with my patrols.

I went back to Peek Rd. by the water treatment plant and sat again with the hopes that the four wheeler would come back. I sat there for about an hour with no luck.

I went and sat in the treeline behind King Lakes subdivision for the remainder of the shift.

- Brief Guideline:
 - I wanted to touch on what the news has been reporting regarding the Astro world concert. You will see below a very brief outline I created for Neil in 2019. These are event planning 101 guidelines. According to reports, several of these steps were left out of the Astro world event planning process. The ones reported, are in red below.

Each venue is unique. These are a few applicable to Central Green:

- Central Green is a wind channel. We have 13mph gust on a regular basis. I take precautions with each event i.e.:
 - Weight of instruments and equipment and how to secure them
 - Sound and how wind will affect the ability to hear show.
 - Sound and ability to hear emergency vehicles and announcements.
 - Sound and surrounding businesses and neighborhoods
 - Sound and feedback, equipment, band quality and what how large of a system is needed.
 - Lighting and its' affect on movie visibility, flow of traffic, ability to see performers.
- I also consider heat, cold, the elements and attendee, performer, teacher and staff health and safety. I offer breaks on an as need basis, provide water for staff and entertainment/teacher. I also have juice and/or snacks available for diabetic and hypoglycemic staff and entertainment.
- Sunscreen is kept in the AV closet
- Staff is trained on electronics and lifting
- Staff is required to read and confirm the safety manual I created was read. There is also staff training.
- Staff is trained on, "tells", by me and Deputies

- Staff is trained on flow of green....main entry points and how evacuation would take place according to human psychological response and how to make adjustments.
- Staff is CPR and AED certified.
- Security, Deputies and staff are scheduled on ratios per anticipated crowd attendance.
- Security, Deputies and staff are placed in areas that can cause problems...in front of stage, back of stage, entry points and area that is high risk of children running out of park, etc.

There are many more safety and event guidelines that take place. Each event is different and to list all would create and endless report. Every event is viewed and accessed per its uniqueness and preparations are made.

I'm also sending you my contacts. I have established these contacts over the years and will be happy to book them or nego price due to relationship or amount of use.

You had mentioned you are planning to use volunteers to work the event. I would put this before Harry. I would suggest yo volunteers. Event Planning Items to Consider:

1. Security - The ratio is 1 employee and 1 Officer per 200 people. You will need to determine how many will be in attendar need to break the park in to quadrants and place an officer and employee(s) in each.

You Must have a Fort Bend Deputy working in the street. Security Guards and Volunteers are not allowed to do this.

- 2. First Aid- You will need to hire Willow Fork EMS
- 3. Staff- Use my Ambassadors

4. Tents- You will want to use APS. They secure the tents better than anyone regarding wind. LaCenterra has faced a laws vehicles. The big concern was a farmers market when one blew away and missed a woman's eye by 1/4 inch. Make sure y APS is the most professional and reliable. They do rodeo, Freedom over Texas, City Hall and all major events in Houston i teams.

APS also has a generator cart, comfort restroom station and handwashing.

You will also need tables and possibly tents and trashcans and clean up for guest of the food trucks.

5. Food Trucks- You need to get a copy of their Fort Bend Health Permit. You need to make sure they follow Fire Marshall MUST also make sure they take their grease traps with them.... I cannot stress this enough. Make sure they do not dump of

You will be required to provide them with restrooms and hand washing in the area they are located. Our restrooms are too

You will need to hire Champions to do clean up during and after event.

Contact: Fort Bend Health for up-to-date guidelines. They change every year. Contact: Dawn at Champions for cleanup quote

6. Transportation- You will need golf carts to help vendors get items to booths. It never fails. A company will send a 70 yea and set up items weighing 50 lbs. It is a long walk for some to get from the parking lot to tents. Make sure you have golf ca

Shuttles for guest. You will want a passenger cart to run through the parking along 99 and the schools parking lots. I saved On-site in the passenger vehicles and having them transport. Some security companies will not agree to this.

Cost: ask On-site

7. Katy ISD- You will need to contact Cyndi Shiffler for approval as well as the Principals of CRHS and CRJHS. If they have student event, they will give you designated parking areas to use.

8. Policing no driving on property- Matt from TBG gave approval along with the Parks Committee to have the tent company and set up tents. There are guidelines on weight and size of vehicle.

10. Schematic, Logistics- You need to consider what each vendor is doing, if you have a speaker and where entertainers v

You will also need to do this for food trucks, tents, tables and chairs, hand washing, comfort stations, generator cart.

11. Forms of Release- Make sure Harry knows who your vendors are and what they are doing. See if they need a Form of

12. Entertainment- I will get a contract and insurance for your band. I will book before 8 weeks.

13. Sound System- Will you be addressing the crowd and using a microphone? This is a great crowd control mechanism if entertainment.

14. Signage- You will want signs along Cinco Ranch Blvd and Westheimer and Commercial Center Blvd. and in the parking to the fair. I have the best and most economical vendor in the business. I can contact him for you once you send artwork, r

15. Marketing- Ask April to do marketing for you. You will need to do this 8 weeks out which means you should have your v correctly. I will have your band booked before this.

16. Unforeseen items- You will need scissors, tape, bungee cords, water for vendors, snacks in case a vendor or staff men provisions, etc.

I ask all vendors to bring water and snacks for their staff. I tell them verbally and send two or more emails listing items nee snacks. They will be asking you for water and snacks throughout the event.

A brief description of putting the event together would be but not limited to;

Communication- this is the most important part of putting an event together. You will need to communicate with Harry, Parl Dawn, vendors, staff, volunteers, contractors, entertainers, sound company, etc.

Determine- theme, goal, entertainment, number of attendees, crowd control, etc.

Risk Management- have a plan for the unexpected.... lake, Frisbee golf and location, heat, wind, rain, walk, heavy items, u

Timeline- load in, activity of guest and how occupied during event, vendor needs, crowd management, etc.

Load out- what is needed for a safe and seamless exit. Police coordination.
