

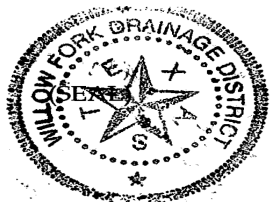
## NOTICE OF MEETING

### WILLOW FORK DRAINAGE DISTRICT FORT BEND AND HARRIS COUNTIES, TEXAS

The Board of Directors of Willow Fork Drainage District hold a regular meeting on **Thursday, July 13, 2023, at 11:30 a.m.**, at the offices of LJA Engineering, Inc., 1904 West Grand Parkway North, Suite 100, Katy, TX 77449, to discuss and, if appropriate, act upon the following items:

1. Comments from the public.
2. Approve minutes.
3. Tax assessment and collections matters, including:
  - a. delinquent tax collections update, installment agreements, and payment of tax bills;
  - b. authorize Execution of Summary Of The 10/20 Year Write Off of Property Taxes Per Texas Property Tax Code Section 33.05 "Limitation on Collection Of Taxes"; and
  - c. adopt Resolution Regarding Development Status for 2023 Tax Year.
4. Financial and bookkeeping matters, including:
  - a. payment of the bills and review of investments;
  - b. resolution(s) expressing intent to reimburse;
  - c. discuss Association of Water Board Directors summer conference, approve reimbursement of eligible expenses, and authorize attendance at winter conference; and
  - d. Resolution Establishing Director Fees of Office and District Reimbursement Policy.
5. Adopt Resolution Voting for Water District Nominee for the Election of the Board of Directors of the Fort Bend Central Appraisal District.
6. Operation of District facilities, repairs, and maintenance, including:
  - a. ditch maintenance and desilting projects;
  - b. discussion of maintenance budgets and, if applicable, approval of any necessary proposals and/or budgets for regular, additional or revised maintenance schedules; and
  - c. approve service agreement between the District and Lake Management Services, LP.
7. Report from Inframark, LLC, including:
  - a. update on status of FEMA claim; and
  - b. maintenance of storm sewer lines, including approval of any necessary maintenance and repair proposals.
8. Engineering matters, including:
  - a. new drainage model and floodplain administrator duties;
  - b. report on outfall inspections and rehabilitation plan and review maintenance chart and authorize appropriate action;

- c. update on USACE Interim Study and authorize necessary action;
  - d. discuss financing of all desilting, repairs, and rehabilitation work due to Hurricane Harvey and authorize appropriate action, including authorize execution of Interlocal Agreement with Grand Lakes Water Control & Improvement District No. 2 and authorize financial advisor to take necessary action to obtain bridge financing, if appropriate; deeds, easements, offsite drainage agreements, consents, including requests to transfer drainage capacity and requests to reserve drainage capacity;
    - i. waterline easement across Va3;
  - e. design of District facilities;
  - f. determine general prevailing rate of wages for engineering construction projects in locality of the District and adopt Resolution Adopting Prevailing Wage Rate Scale for Engineering Construction;
  - g. review bids and award contract for construction of the following:
    - i. haul of fill from Harris County Diversion Channel cleanout project.
  - h. status of ongoing improvements and repairs to District facilities, including approve pay estimate, change order, and final acceptance and direct engineer to notify insurance company of new facility for the following:
    - i. Va1, Va9 and Va12 Slope Erosion.

  10. Flood mitigation efforts including community outreach and authorize appropriate action, if applicable.
  11. Park Matters related to drainage improvement projects and/or maintenance of drainage facilities used for recreational purposes.

    - a. Houston Stronger report; and
    - b. report on current events.
