 - f. authorize appropriate action regarding shade structure at Central Green;
 - g. authorize design of new projects; and
 - h. discuss Harris County Precinct 4 grant.

 - c. Phase II Small MS4 General Permit and Storm Water Management Plan, including status of compliance, necessary training, public comment, and approval of year 3 annual report and public education materials.

11. Report regarding Central Green events and Parks Committee recommendations and approve contracts for events, as appropriate, discuss park operations, park assistant matters, and authorize appropriate action.
12. Committee Matters, and authorize appropriate action.
13. Approve and authorize filing of education/training compliance status for Board of Directors with the Fort Bend County Drainage District.

15. Meeting schedule, action items, and items for inclusion on the next agenda.
